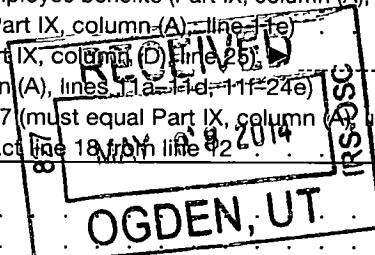

Spay/Neuter and Vaccinations - Dallas Companion Animal Project's Spay/Neuter programs provide free and low-cost spay and neuter surgeries and vaccinations for unaltered pets belonging to low-income Dallas residents. These programs include twice-monthly, high quality, high volume, spay/neuter clinics as well as periodic vaccination clinics. Spay/neuter reduces the number of unwanted pets born each year - a critical component in reducing the number of homeless pets euthanized.

4b (Code:) (Expenses \$ 11456.68 including grants of \$) (Revenue \$)

Community Outreach - Dallas Companion Animal Project's community outreach programs include providing pet food and resources for homeless and low-income pet owners served through the Crossroads Community Center in downtown Dallas; The Lucy Fund, which provides emergency veterinary care for ill or injured animals whose owners are unable to afford treatment; and the Pets For For Life program, a target outreach program that embraces the human component of the human-animal equation by approaching in a respectful, non-judgmental way, no matter what their socio-economic circumstances or cultural differences may be.

Pet Placement Partner Support - Dallas Companion Animal Project serves as the "Friends of" group for the City of Dallas Animal Services Division, assisting the division with fundraising for equipment, services and supplies over and above what is provided for by the City of Dallas, and providing volunteer manpower to enhance and expand shelter operations. DCAP also provides capacity-building programs, training, and support services for more than 50 of North Texas 501c3 non-profit animal welfare organizations.
